World leaders concerned over Israel's 'unilateral steps' in East Jerusalem

Top diplomats see **Israel's public call for tenders** to build 1,257 new settlement **homes** in **East Jerusalem's Giv'at Hamatos neighborhood** as a 'step that sends the **wrong signal at the wrong time**'

Germany's foreign minister warned Tuesday against unilateral **steps** that could **hurt** Mideast **peace talks** between **Israel and the Palestinians** following the **change in** administration in the **United States**.

U.S. President Donald **Trump** has strongly **backed Israel** during his four-year term, declaring Jerusalem the Jewish state's capital, tolerating Israeli settlements in the West Bank and pushing Arab countries to normalize relations with Israel.

"Creating facts unilaterally won't help us in this already difficult situation, **Germany's top diplomat, Heiko Maas**, told reporters after **meeting with his Palestinian counterpart in Berlin**. "But no doors should be slammed shut either, in view of developments in the United States."

Maas didn't spell out what unilateral measures he was concerned about. But on Monday, his office criticized Israel's public call for tenders to build 1,257 **new settlement homes** in East Jerusalem's Giv'at Hamatos neighborhood as a "step that **sends the wrong signal at the wrong time**."

Maas noted that U.S. president-elect Joe **Biden agrees** with Germany's position that a negotiated **two-state solution** should be the **basis for peace** talks between the parties. The **Palestinian** foreign minister, Riyadh al-Maliki, said he **sees** in **Biden's election "a window of opportunity**, and we want to take advantage of that window of opportunity in order really just to open a new page."

Al-Maliki added that "we suffered tremendously, as Palestine, from Trump's policies."

Meanwhile, Saudi Arabia's Ministry of Foreign Affairs on Tuesday voiced "deep **concern**" over **Israeli** authorities' decision to **invite contractor bids in East Jerusalem** and said it contravened international resolutions.

"The ministry affirms the Kingdom's condemnation and rejection of the move, which contravenes international resolutions," it said in a statement.

Israel moved ahead on Sunday with a settler housing plan in the area, a step critics said aimed to **shore up the project before** U.S. President-elect Joe **Biden takes office**.

The United Arab Emirates, Bahrain and Sudan earlier this year signed agreements toward normalizing relations with Israel in a strategic realignment of Middle Eastern countries against Iran.

Riyadh has quietly acquiesced to the UAE and Bahrain deals "though it has stopped short of endorsing them" and has signaled it is not ready to take action itself.

Explosion at Ashdod's industrial zone leaves 2 dead

Police says 2 more people were moderately wounded in what appears to be a work accident at the local metal recycling plant; preliminary investigation raises suspicion the business was operating without a license

An explosion that occurred Tuesday morning at an industrial zone in the southern city of Ashdod left two people dead, said the Israeli police.

Two others were moderately wounded in what appears to be a work accident at the local metal recycling plant.

A preliminary investigation showed the blast was caused by two gas canisters but the probe into the incident is still ongoing. Sources said one of the suspicions is that the business was operating without a license.

Magen David Adom paramedics who were called performed CPR on the two victims but ultimately were forced to pronounce their deaths at the scene.

The two workers, who sustained moderate injuries to their limbs, were evacuated to Samson Assuta Ashdod University Hospital. Another person was lightly hurt.

"When we arrived at the scene, we saw destruction," said Matan Cohen, an MDA paramedic who was one of the first at the scene. "A 35-year-old man was rescued by people at the location, while being fully conscious and suffering from a moderate leg injury.

"We put him in an ambulance and urgently evacuated him to a hospital as he was receiving life-saving treatment ... later he was sedated."

The hospital said the condition of one of the injured is stable.

"A few minutes ago, the hospital received a moderately injured patient with limb injuries. In light of his injury, he needed to be sedated and given respiratory support," said the hospital in a statement.

Netanyahu says scheduled to speak to Biden for first time since election win PM, Biden call set to center around Israel's intentions to build new East Jerusalem housing units; Netanyahu tells reporters he spoke with Russian President Putin on procurement of COVID-19 vaccine

Prime Minister Benjamin Netanyahu said on Monday that he has been told he will speak to U.S. President-elect Joe Biden soon.

The premier, who often boasts his close ties with Republican President Donald Trump, has acknowledged the veteran Democrat's victory in the recent U.S. election for the first time after he was asked during a press conference about Israel's intentions to build 1,257 new housing units in the settlement of Givat Hamatos which is located over the Green Line, and is considered a neighborhood of East Jerusalem.

"We usually update the current administration in Washington on construction plans and they knew about this one as well," Netanyahu said. "I announced it at the time." Israel cast a wider net on Monday in its quest to secure a vaccine for COVID-19, approaching Russia to discuss buying its Sputnik V vaccine.

"About an hour ago, I spoke with Russian President Vladimir Putin regarding the possibility of purchasing an option on the vaccine Sputnik-V," Netanyahu told reporters. "We will discuss this in the coming days."

An official statement by Kremlin said that Netanyahu and Putin discussed the measures taken by both countries to rein in the spread of COVID-19 and future Russo-Israeli cooperation on the distribution and production of the Russian vaccine.

"The two leaders focused on efforts to counter the spread of the coronavirus. They had a detailed discussion of the restrictive and preventive measures the two countries were taking," read the statement. "Bilateral cooperation between interested agencies and organizations were discussed, in particular, the prospects for cooperation regarding the Russian vaccine, including distribution and production in Israel.

Israel was early to sign with U.S. pharmaceutical giant Moderna Inc for its potential vaccine, reaching an agreement in June. Last week it signed another deal with Pfizer Inc. Both companies have reported encouraging trial results.

Israel is also developing its own vaccine that, if successful, could be market-ready by the end of the summer.

"My goal is to bring as many vaccines from as many sources to as many citizens, as quickly as possible," Netanyahu said.

Itinerary for upcoming Pompeo visit infuriates Palestinians

Top U.S. diplomat set to visit West Bank settlement of Psagot, becoming the first one ever to do so; Palestinian PM warns visit would set a 'dangerous precedent' in violation of international law

Palestinian Authority officials are enraged by U.S. Secretary of State Mike Pompeo's plan for a visit this week to an Israeli-operated winery near Israeli settlements in the West Bank, which are considered illegal by most of the world.

Nabil Abu Rudeineh, spokesman for Palestinian President Mahmoud Abbas, said on Sunday that Israel was "trying to benefit from the unlimited support" of the Trump Administration "for the sake of settlement expansion and the takeover of more Palestinian lands" in the West Bank.

"This American administration has become a fundamental partner in the occupation of the Palestinian lands. Neither this visit nor any U.S. support for Israeli settlements in Palestinian lands can give legitimacy to the settlements or change the fact that they are doomed to end."

Palestinian Prime Minister Mohammed Shtayyeh said on Friday that the visit would set a "dangerous precedent" in violation of international law, calling it a way to "legitimize the settlements."

On Monday, Pompeo is scheduled to visit the Psagot Winery, located about four miles southeast of a settlement of the same name, which itself is just east of the city of Ramallah in the West Bank.

It will mark the first time a secretary of state travels to a settlement area in contradiction to the policies of previous U.S. administrations. It comes exactly one year after he announced that Washington no longer considered settlements illegal.

The decision puts the U.S. at odds with UN Security Council resolutions and almost all other countries aside from Israel.

He will also be the first secretary of state to travel to the Golan Heights, whose de facto annexation by Israel was recognized by President Donald Trump in March 2019.

Dr. Hanan Ashrawi, a member of Palestine Liberation Organization Executive Committee, stated that Pompeo's visit represented a violation of international law.

"It is a participation in the war crime that Israeli settlement constitutes under international law," she said.

Ashrawi has threatened to submit an official Palestinian complaint to the United Nations against Pompeo, saying such a visit "reflects the aggressive and lawless behavior of the [Trump] Administration in its endeavor to reap the largest number of gains for Israel before leaving the White House."

Trump implemented a radical shift from past administrations' policy on the Israeli-Palestinian conflict. He recognized Jerusalem as the capital of Israel in December 2017 and relocated the U.S. Embassy to the city in May 2018, leading the Palestinians to sever ties with his administration.

Mustafa Barghouti, secretary-general of the Palestinian National Initiative, a political party, said that although the Trump Administration will soon be out of office, it is continuing to act against the Palestinian cause and prove that it is "not an honest broker." "This is a violation of international law," he stated.

"One more time, Trump and his administration make themselves participants in the violation of international law by Israel, and this shows how dangerous the coming 68

days are [before a Biden administration enters office], because Trump and his team can commit any kind of aggressive actions against the Palestinian people, of course with the encouragement of [Israeli Prime Minister Benjamin] Netanyahu,” Barghouti said.

The Palestinians must “be alert, and we have to do everything we can to stop this administration from carrying out more serious aggressions,” he added. Ashrawi says the Trump Administration “insists on supporting the acceleration of settlement expansion in the occupied Palestinian territories in a manner that expresses the apex of immorality and distorts political and legal positions in the service of Israel.” Pompeo’s trip comes two months before the inauguration of President-elect Joe Biden, a past critic of settlements who has pledged to put more diplomatic effort into creating a Palestinian state.

The Psagot Winery was at the center of a dispute when it unsuccessfully challenged a European Union decision to label all products from settlements in the Palestinian territories as not originating in Israel. Psagot later rolled out a limited edition of wine named after Pompeo in appreciation of his position.

Hassan Awwad, a U.S.-based expert on the Middle East, said that the visit will complicate matters before Biden takes office.

“It will make the job of the incoming administration more difficult as it tries to kick-start peace talks between the two sides,” he explained.

Awwad argues that Pompeo is acting to advance his personal ambitions.

“He is thinking about his own political future and is looking ahead to 2024. That explains his action, which is aimed at pleasing the evangelical base,” he noted.

Barghouti was more cutting in his criticism.

“All politicians think about their own interest, and he [Pompeo] is no different, but the more important question is why there’s such a base of racists in the United States who support the worst kinds of violations of human rights and the worst kind of violations of international law.”

Israel’s settlement enterprise is a prominent aspect of the Palestinian-Israeli conflict and one of the main reasons the PLO suspended peace negotiations in 2014.

Pompeo’s 10-day tour of the region also includes stops in Turkey, Georgia, the United Arab Emirates, Qatar and Saudi Arabia.

Argentina tightens border security over bomb plot targeting Jews

Anonymous tip warns authorities of person seeking to ship ammonium nitrate from Paraguay 'for a bomb with a Jewish objective,' country's Security Ministry says; investigation launched to find the individual mentioned

Argentina said Saturday it would tighten security at its border with Paraguay after its embassy in the United Kingdom received an anonymous tip alerting authorities to the possibility of bomb-making materials entering across its northern border.

The tip warned of a person seeking to ship ammonium nitrate from Paraguay to Argentina "for a bomb with a Jewish objective," the country's Security Ministry said in a statement.

Authorities said they had launched an investigation to identify the individual cited in the tip. Argentina has the largest Jewish population in Latin America. In 1994, a car bomb exploded outside the AMIA Jewish center in Buenos Aires killing 85 people. The bombing was attributed to Iran but no indictments were handed down. In 2004, Alberto Nisman was appointed senior prosecutor and reportedly discovered that senior Argentine government officials were involved in a major cover-up of Iranian agents behind the attack.

He also collected testimony against the heads of the Iranian regime, based on incriminating evidence from former Iranian president Seyyad Abolhassan Banisadr, various diplomats, Iranian opposition sources, Iranian intelligence official Farhad Mesbahi and from heads of the Iranian operational network in Europe. The latter's testimony was the most important card in presenting Nisman's evidence to the heads of Interpol and convince them that he had connected enough material that would incriminate the Iranian government leaders responsible for the attacks that took place in Buenos Aires.

"The most senior officials involved in the prosecution, members of the intelligence service along with my government conspired to disrupt the discovery of the truth about the Iranian connection and avoid bringing those responsible to justice," Nisman told Ynet's sister publication Yedioth Ahronoth in 2007.

Nisman was found dead under suspicious circumstances in 2015, a day before he was set to participate in a closed-door congressional hearing surrounding his investigation into the perpetrators of the attack.

Two years prior to the AMIA bombing, another car bomb exploded outside the Israeli embassy in the Argentinian capital, killing more than 29 people.

Jerusalem court holds hearing on Netanyahu's corruption cases

Hearing on preliminary arguments scheduled for December 6, evidentiary phase scheduled to begin in January 2021, but PM's request to amend indictment against him may lead to further delays

The third hearing in Prime Minister Benjamin Netanyahu's corruption trial was held in Jerusalem District Court on Sunday.

Both sides briefed the court on developments in investigation materials and have set dates for future discussions.

A hearing on the preliminary arguments is scheduled for December 6 and the evidentiary phase is scheduled to begin in January 2021, but in light of Prime Minister Netanyahu's request to amend the indictment against him, his defense attorneys may seek to postpone further proceedings.

Defendants were exempt from appearing at the hearing. Due to coronavirus restrictions, the hearing was screened for the media in a separate courtroom.

During the hearing, Netanyahu's attorney Boaz Ben Tzur tried to raise several issues, including a request to remove the confidentiality of the investigation materials, but judges kept interrupting any attempts to filibuster the hearing and tried to keep it focused and concise.

Netanyahu has been indicted earlier this year for allegations of bribery, fraud and breach of trust in three corruption cases, also known as Cases 1000, 2000 and 4000.

Case 1000 alleges Netanyahu has received expensive gifts worth up to NIS 1 million from Israeli-American producer Arnon Milchan and Australian billionaire James Packer.

Case 2000 concerns alleged discussions between Netanyahu and the publisher of the Yedioth Ahronoth group Arnon Mozes over positive media coverage in return for Netanyahu weakening Yedioth's main rival the Sheldon Adelson-owned Israel Hayom.

Case 4000 involves an alleged plan to ease regulations for telecommunications mogul Shaul Elovitch in return for positive coverage on the Walla! news website.

Last Thursday, Netanyahu's attorney demanded that the prosecution strike from the indictment any alleged transgressions involving the Netanyahu family or his wife Sara, and refer only to issues involving the prime minister himself.

The demand came after witnesses testified that the prime minister had no knowledge of the actions of his wife and son Yair in one of his cases, and had even objected to them upon learning about them.

The premier's defense team argued in petitions regarding the indictments in Case 1000 and Case 4000 that the indictment includes evidence in clear contrast of the law and blamed "a flawed and tendentious investigative procedure and considerations that are in conflict with the principles of justice and legal fairness."

They also demanded that the prosecution detail the benefits the parties exchanged in Case 1000 and Case 4000.

"Only providing details in this regard will allow the prime minister to formulate relevant lines of defense and determine what evidence he will seek to present, and only then will a complete and clear picture be presented to the court," the request said.

The prosecution said in response that the request will be answered during the preliminary arguments phase.

Britain's Prince Charles makes private donation to Peres Center for Peace

Heir apparent's private donation for an undisclosed sum marks first time palace makes any donation known to public and the first time a member of the royal family makes a private donation to an Israeli cause

Heir apparent to the British throne Prince Charles made a private donation to the Peres Center for Peace and innovation on Wednesday - marking the first time a member of the British royal family has made an official personal donation to an Israeli cause.

While donations from the British royal family are usually made through funds and are kept confidential - the palace has chosen to make Prince Charles' personal donation publicly known - though the specific amount donated was not disclosed.

Prince Charles is known as a friend to Israel and has visited the Jewish state numerous times throughout the years.

The heir apparent has attended Shimon Peres' funeral in 2016, with his last visit being in January of this year as part of the World Holocaust Forum held at Yad Vashem to mark the 75th anniversary of the liberation of the Auschwitz-Birkenau Nazi concentration camp.

During his latest visit, Charles has also paid a visit to the grave of his grandmother, Princess Alice, who is buried in the Mount of Olives in Jerusalem, Judaism's oldest and holiest cemetery.

"The contribution to the Peres Center reflects the impact of the prince's visits to Israel, and the importance of the relations between Britain and Israel," said British Ambassador to Israel Neil Wigan.

The Peres Center for Peace was established in 1996 by late president and prime minister Shimon Peres, who was knighted in 2008 by Prince Charles' mother, Queen Elizabeth II, for his extraordinary work in advancing peace.

The chairman of the Center for Peace, and Peres' own son, Chemi Peres published a statement thanking Prince Charles for his donation.

"It is a great honor to be the first Israeli organization to receive a donation from a member of the British royal family. The generosity of His Excellency Prince Charles allows the center to continue to promote Shimon Peres' legacy for a better future for all of us," Peres said.

"Especially in the midst of a global pandemic, it is important to reach out to others, even between countries and across borders. I thank Prince Charles for choosing to walk hand in hand with us on the path of peace and innovation."

WHO meeting devolves into attack on Israel

Among those blaming Israel for violating health rights of Palestinians and Syrians are Venezuela, Iran, Syria, North Korea, Cuba, Malaysia and Lebanon - all of which are embroiled in civil war, political strife or human rights violations

Some of the world's worst human rights abusers condemned Israel for allegedly harming Palestinian and Syrian health rights, during the World Health Organization's Thursday meeting on the global response to the COVID-19 coronavirus pandemic.

According to a UN Watch report, among the 30 delegations who blamed Israel for "allegedly violating the health rights of Palestinians and Syrians in the Golan Heights" - are Venezuela, Iran, Syria, North Korea, Cuba, Malaysia and Lebanon - all of which are embroiled in civil war, political strife or human rights violations

The session concluded with a vote of 78 to 14, with 32 abstentions, to adopt a resolution, co-sponsored by Syria, Cuba, Turkey, Qatar and the Palestinian delegation, requiring the WHO to hold the same debate at next year's assembly, and to prepare another report on the "Health conditions in the occupied Palestinian territory, including east Jerusalem, and in the occupied Syrian Golan."

Hillel Neuer, executive director of the Geneva-based NGO UN Watch decried the "cynical politicization of the world's top health agency at the expense of focusing on the COVID-19 pandemic and other vital global health priorities and emergencies."

Neuer maintained that not only are the claims that Israel is abusing Palestinian health rights false, but that opposite is true, adding that the attack seemed exceptionally galling, considering that the UN's "own Middle East peace envoy hailed Israel's 'excellent' coordination and cooperation with Palestinians amid the coronavirus pandemic."

Neuer was also dismissive of the claim that Israel routinely harms the health rights of Syrians fleeing to the Golan from President Bashar al-Assad's brutal regime, saying that Israel's now-defunct program, "Operation Good Neighbor", either secretly provided

medical treatment for thousands of Syrians in Israeli hospitals or treated them at the border.

Netanyahu: Pfizer's coronavirus vaccine will arrive in Israel in January

PM urges Israelis to not grow complacent and continue adhering to virus rules since jab's distribution to general public could still be months away due to high global demand, says Israel on the look to acquire vaccines from other sources as well

Prime Minister Benjamin Netanyahu on Thursday announced that the first batch of U.S. pharmaceutical company Pfizer's newly developed coronavirus vaccine will arrive in Israel in January.

"It will only grow from month to month," Netanyahu said in a video announcement. "We are also looking to acquire vaccines from other sources. The more the merrier."

The premier also warned Israelis to not grow complacent and continue adhering to coronavirus regulations since the distribution of the vaccine to the general public could still be months away due to the high global demand for Pfizer's jab.

"Since this will take time all over the world, we must follow the rules," Netanyahu said. "I insist that lifting restrictions should be done in a gradual and responsible manner. I want to open the economy, trade and all the rest as much as anybody, but we must do it responsibly, or else will just go back to where we were."

Pfizer Inc said last week its experimental COVID-19 vaccine was more than 90% effective, making the company and its German partner BioNTech SE the first drugmakers to release successful data from a large-scale clinical trial of a coronavirus vaccine.

Netanyahu spoke on the phone with Pfizer CEO Albert Bourla and the company's legal counsel twice in 24 hours in an attempt to remove all barriers and bureaucratic difficulties and sign an agreement allowing the procurement of millions of doses.

Various countries around the world, including the U.S., UK, Canada and Japan among others, have already signed a preliminary agreement with Pfizer to purchase the vaccine once it receives approval.

The EU is set to receive 200 million vaccine doses for its member countries and has an option to purchase another 100 million.

The new agreement joins other deals the Jewish state had inked with U.S. drug manufacturers Moderna and Arcturus who are also in the last stages of developing a COVID-19 vaccine.
