

Ideas to use in Political Platform Promises

- 1- Eliminate the gasoline nuisance tax of 9/10c. Either raise it 1 mil or lower it 9 mil. When gas was 9 cents, the mil (1/10th cent) was a common coin. Since the 1, 2 & 5 mil coins were removed, the 9 mil tax has been a deceptive retail calculation nuisance.
- 2- Border protection: We have hundreds of military bases, and many in each state that do nothing to protect that state, but are used for training or storage. Gradually move assets to start a base each 50 or so miles along our problem borders. Every country does this, and military can sustain a practical fence with a permanent patrol of barriers by existing troops. Training grounds are along the border between bases. A city will NOT have direct access to a hostile border; it will be buffered and maintained by a military screen.
- 3- Define the laws and rules for ALL foreign visitors and immigrants. Our policy should apply restrictions that parallel what their home country's rule is on foreigners. Visitors of a friendly nation, like Canada, will be openly accepted. A harsh nation of Arabs should have more restrictive criteria. ALL non citizens committing heinous crimes will be under military rule, evicted or incarcerated or executed, and NEVER allowed to return or run free in this country.
Immigrants do NOT have rights to our courts unless they are a US citizen. Our national culture is not always in the heart of an individual, and our peaceful culture and English language are part of the heritage of America. All immigrants and visitors may be measured and rejected by Federal or State officers for their political, religious, and cultural views. All immigration shall be filtered and accepted through EACH adopting State's immigration office. Each State shall preset an annual maximum and selective quota and criteria, to ensure the STATES are in control of their borders, culture, education, and economy. No State or Court shall be burdened with migration or immigration complications without their specific accepting consent. These restrictions are pre-existing within the State's rights given by the Constitution Article-1, Section-9.
- 4- Re-read our Constitution! Military is not to be expanded EXCEPT in times of war. We have not had a declared war since WW-2. The military's continual purpose is to protect our borders and our states, not patronize the planet. A military base is not to exceed a ten mile square of exclusive jurisdiction. (Constitution Article-1, Section-8 and Section-9)
- 5- NEVER train or support or supply any foreign troops of Islam nations!!! In every war, where the victory was obvious, the FIRST step was to remove all the enemies' communication and media. Then conservative republican views and culture were broadcast continuously to train their younger generation to embrace the victor's culture. Do not allow an enemy to perpetuate their culture, and the media culture switch must start BEFORE troops are introduced. (Constitution Article-3, Section-4)
- 6- Eliminate inheritance taxes! People have a right to build a heritage that cannot be infringed upon. This is a biblically based concept. ALL donations to ANY group are a gift, and NONE should be tax deductible, nor taxes imposed to the recipient.

7- Sell off US land to heritage families of this nation, to which both maternal and paternal generations have resided in the US for over 100 years. These lands would be similar to the existing US Indian Nations. We the people are to maintain what are now vast federal territories. We are to populate the land and encourage heritage families. Families will eagerly use massive savings to secure and improve an un-taxable heritage land of their own. Do not allow federal funding to assist in the purchase or improvement of these lands, except for the interconnecting highway system. Monitor the activities at a minimum to ensure resource harvests are not detrimental to the future value of the heritage lands, and the adjacent lands are not harmed, and the cultural activities are not damaging to our nation. These lands must be independent of County or City control and taxes, but subject to the parent State.

8- Watchdog and IMMEDIATE removal of rogue Judges, Politicians, and Enforcement Officers at any level, in all State and Federal offices. That is already a requirement in the Constitution. Impeachment votes declare they are never again allowed in any public office. A trial after impeachment is only to derive punishment, not the guilt, which was determined at impeachment vote. (Constitution Article-1, Section-2-3 & Article-2, Section-2 & 4, & Article-3)

9- Rework the Judicial System of Trials. The legal rules have perverted the laws, where the whole truth is rarely examined. Age, Afflictions, Bartering before trials, and micro selection of Juries, allows preferential manipulation of evidence presented for Judgment. All evidences should be presented to a well informed jury of community leaders. Any restrictions of evidence should be deemed as an accomplice to the crime.

10- Eliminate Federal minimum wages, and let the market run the natural values. Only the States should assess and control their budgets and welfare.

11- Eliminate all balancing preference in all laws to race or gender, and let the physical and mental requirements select the needs. Government and businesses and private individuals may and should consciously and discriminately select their helpers to their specific needs. ONE law for all without pre-determined preferences or coercing tax adjustments.

12- School bussing to meet quota and fairness criteria is a flawed idea that is corrupt, costly, and wasteful. Eliminate federal requirements for bussing, and let the state and local boundaries assume their own logistical needs through their own criteria. This could immediately relieve a large portion of some local tax burdens. School sports are a popular trend, but extremely high cost of school budgets, and yield no true education. In most large communities, most of the local taxes are for schools, and often the majority of school tax is for the sports infrastructure and sports transportation. Reduce federal support for any school with this corrupted system.

13- Any business or individual has the right of conscious to refuse services or discriminate acceptance to any individual to their own guidelines, provided that these

guidelines are made public if made by a business. No business or individual shall be forced to accommodate any client that is contrary or offensive to their goals.

14- Any threat or aggressive lawsuit that is not deemed valid, but intentional harassment to oppress by invoking a legal court battle; the court shall charge the activists with the punishment that the accuser intended to impose on others. A false witness or false statement used in court, will invoke a punishment on the falsifiers that they intended to impress upon their intended victim. This is a biblical concept.

15- All representatives and staff in Congress shall be paid by their respective state. They shall not draw funds from the federal sources except in federal assignments. This change would require an amendment to the Constitution Article-1, Section-6. This would return the enumeration of the State's representatives to each State, as was first given in the Articles of Confederation, that existed before the Constitution.

16- All lobbyists of the Federal Congress shall be approved through the respective State's governor and representatives before consulting the State's representative of Congress. The State's Governor and House of Representatives shall monitor and be duly informed of all lobby requests of their State's Federal Representatives.

17- No Federal Politician should leave the United States without public approval of Congress. No private or concealed travel is allowed, and no President is allowed foreign travel without a majority of Congress in agreement.

Political Rally's and Speeches:

A long winded and repeated speech is like and old stew; while a fresh flavor is a delight. Trump gives a new flavor, while the old dogs spin the same yarn over a soured corpse.

Liven up speeches by testing your potential Cabinet Members or Mentors. Let them fill in some gaps on details within their expertise. A Mentor's delivery might invigorate with their specific answers, yet their statements are not held as campaign promises.

Acknowledge at the start that you may not agree with all that they say, but you are giving them a chance to sell their position to your platform.

You are the leader and you will steer the solutions, and select your Cabinet from their delivery of ideas to the public. This public forum allows you to show leadership, but not get bogged in perpetual stumbles. Essentially, the Cabinet Members & Mentors are an extension of your running mates, like the Vice-President.
